This letter is sent in response to a submittal dated August 3, 2012, and received on August 6, 2012, by the Missouri Department of Natural Resources' (Department) Solid Waste Management Program (SWMP). It was submitted by F. Daniel Brennan, P.E. and sealed by Deborah A. English, P.E. of SCS Engineers. This submittal was in response to a comment letter sent to you, dated July 11, 2012, from the SWMP. The submittal contained a response to comments letter and revisions to previous submittal to install additional gas wells to help control odor issues due to the Subsurface Smoldering Event (SSE) and to help reduce the gas migration issue at the landfill.

The SWMP had questions on the submittal. In an email received on September 11, 2012, F. Daniel Brennan, P.E., with SCS Engineers explained the procedures for getting the equipment on the FML lined areas and how the drilling will take place in those areas.

On August 22, 2012, Department staff visited the landfill to observe the conditions and continuing physical changes at the landfill and to discuss the next steps in controlling the SSE.

The SWMP has reviewed this report in accordance with the Missouri Solid Waste Management Law and regulations. The SWMP hereby <u>approves</u> this modification to the gas extraction system at the Bridgeton Sanitary Landfill with the following conditions. Compliance with these conditions will, in part, determine compliance with Solid Waste Disposal Area Permit Number 0118912.

## **CONDITIONS:**

1. The SWMP requires the temperatures and depth of each shovel from each well to be recorded as it comes out of the waste and to be submitted with the CQA report.

2. Smoking, smoldering or hot waste excavated may not be transported to a landfill for disposal until the waste is no longer smoking, smoldering or hot.

- 3) An email received on September 11, 2012 from F. Daniel Brennan, P.E., with SCS Engineers pertaining to the drilling in areas that are covered with FML.

The SWMP understands that there may need to be field modification made while installing this system because of site conditions and location of the SSE. Please contact the SWMP before any major modification is made to this plan.
